In 2014, UCSA conducted several student-led campaigns: IGNITE- Invest in Graduation Not Incarceration, Transform Education. IGNITE aimed to pass several bills and a senate constitutional amendment, and to urge the UC Office of the President to allocate \$10 million to student run recruitment and retention centers.
