Good morning all, apologies for not sending out this update. There's been a lot of movement related to undocumented students. PJN met with undocumented students to understand what they need with the incoming administration. We then released a set of principles.

The day after the election the UC formed a workgroup with the goal to figure out the path of the Trump admin. Yesterday was the deadline to submit the expenditure support for how the UC plans to help UC students. We also received similar report for Basic Need. In December there was a Mental Health Summit. There is a new form for reimbursement which has been reduced.

Is there a way to follow up if our own campus did not submit the report? Davis for example needs extension following the election.

What is ucop's effort to prevent islamophobic hate crimes? We have met with MSA's and will follow up with action items.
