SB 1232 sets out to provide aid to student parents who have been identified as one of the most vulnerable student populations affected by COVID-19. Streamlining access to CalWORKS for student parents would be a great way to help these students access the funds they need to sustain themselves while navigating the COVID-19 pandemic.

That is why SB 1232 is a timely and effective legislation: It addresses a long-existing barrier to the CalWORKS program for student parents that hinders their ability to enroll in and maintain their eligibility in the program despite their clear need.

Currently, The requirement for full-time student parents is to have to work an additional 20-30 hours on top of their school to receive full CalWORKs benefits. Additionally, they have to prove the completion of these hours through a mountain of hurdles and unnecessary bureaucratic processes. These old and antiquated requirements that simply do not take into account the amount of work full-time student parents have to invest in their education and their familial responsibilities. Leaving student parents unable to benefit from the CalWORKS program and finically constricted.

Put plainly, this fight is about providing the very much needed and essential aid student parents need.


